# Image 10, 11 Casualty form active service

Usual inf. Enlisted for duration of war.

Left Avonmouth on 8/5/1916 on HMS City of Chester. Disembarked Basra 9/6/16. (took part in Battle of Jutland and severely damaged 31<sup>st</sup> May 1916. on the way)

Invalided to India 9/7/16 per hospital ship. Hospital in Amaria (Uttah Pradesh. (East of Delhi) (Near mountains, possibly thought to be beneficial) suffering from chronic otitis media – chronic inflammation of middle ear.

30/4/17 Embarked on "SS Elephanta", Bombay 7.4.17 arrived Basra 15.4.17. Joined 72st field company Basra 24.5.17. Joined unit on service as reinforcement 20.5.17.

12.6.17 To hospital at Sindu Yeh, Iraq. Discharged from Amarah (had bronchial pneumonia) 19.8.17.

24.8.17 Admitted to Amarah with Sc fever. Re-joined unit in Sindu Yeh 3.10.17

26.10.18 he was admitted to hospital and discharged 2.11.18.

On 7<sup>th</sup> April 1919 embarked on SS Elephanta for passage to United Kingdom. Struck off the strength of the force.

Transferred to reserves Class Z 2-12-19. Home address 1 Sharpes Yard.
