L/AC Thomas Hind - service record

Two images survive giving a brief summary of Hind's description, next of kin and promotions.

Image 1 records that he had previously served in the army, having signed up on 23^{rd} July 1917 for the duration of the war. He transferred to the Royal Flying Corps on 12^{th} December 1917 and to the RAF on its foundation on 1^{st} April 1918.

His occupation was Joiner. He was unmarried and "the person to be informed of casualties" was his father, WP Hind of Moor Lane, Bingham, Notts. [The family had moved from their 1901 residence at Bottesford to Moor Lane, Bingham in 1911 census].

Thomas was 5 feet 5 inches tall with a chest of 32".

He was transferred to the RAF reserve on 27/9/19 and was deemed discharged on 30th April 1920.

He seems to have been initially assigned to W EX (Wireless Experimental Establishment), Biggin Hill and was transferred to Ripon DC on 28/8/19. [WEX developed the use of wireless between the ground and aircraft using early Marconi equipment. It was the scene of a strike and mutiny over camp conditions in January 1919 - http://libcom.org/files/1919%20The%20RAF%20Biggin%20Hill%20mutiny.pdf]

Image 1 also records his promotions. He was "reclassified AC II (Carpenter) on 1/1/19, AC I on 19/5/19 and LAC on 1/7/19.

His medical category was A1.

Image 2 records he was awarded the British War and Victory medals.
